RE: MIDDLE SCHOOL PLAY STRUCTURES

## **RECOMMENDATION:**

THAT the Board of Education provide each Middle School (ADR, CMS, MSMS, VMS) with a base amount of \$75,000 for Middle School Play Structure capital costs. The district will install the structures.

## **BACKGROUND:**

Chilliwack School District Middle Schools have limited outdoor play structures for students. CMS, ADR, and MSMS have no play structures. VMS has a traditional playground. Rosedale (K-9) has extensive playgrounds and play structures.

The base amount for each Middle School play structure will provide a significant starting place to begin the development of outdoor Middle School play spaces. We anticipate that PACs may have difficulty raising sufficient funds to cover such a large expenditure. The B.C. government is currently reviewing how school playgrounds are funded and built. Announced in October, their aim is to fund replacements and upgrades from the provincial education budget. If approved, the Minister has said that the playground fund will be included in the government's February 2018 budget.

With the reconfiguration of Chilliwack Middle Schools to grades six to eight in fall 2018, play structures have been identified by staff and parents as an emergent need for middle school students. Middle school students experience rapid growth and development during adolescence. As such, middle school playground equipment should focus on activities that promote exercise and social play. Ideally these activities are challenging yet achievable. For this reason, play structures for middle school students generally are different than the traditional playground equipment found on most elementary school sites.

Studies show that school age students who have at least 15 minutes of recess a day are better able to self-regulate and learn in classroom environments due to these 7 reasons:

- 1. Everyone needs a break
- 2. Recess increases focus
- 3. Natural light improves wellness
- 4. Recess reduces stress

- 5. Recess develops social skills
- 6. Exercise is healthy
- 7. Physical activity feeds the brain
