#### **RECOMMENDATION:**

- 1. Acknowledges that human activity is contributing to rapid global climate change.

#### **RATIONALE:**

We are currently facing the effects of human-caused climate change and there is limited time to act before the damage is irreparable. At the last climate strike, hundreds of our students attended and spoke. Their knowledge and passion were inspiring, and we should show our support. Since November 29 is a non-instructional day, students can participate in this strike without missing school; this could allow more students to participate, as they will not have to worry about loss of other learning time. Part of our job in education is to raise engaged citizens. This is a simple gesture to support that goal.

# BOARD OF EDUCATION School District #33 (Chilliwack)

# 211 POLICY Regular Public Meetings

- Regular Board meetings will begin with an acknowledgement of Traditional Stó:lō Territory.
- 2. The Board of Education shall determine annually the schedule of regular Board meetings for the following school year.
- A quorum of the Board is a majority of the trustees holding office at the time of the meeting.
- 4. At the appointed time for commencement of a meeting the presiding officer shall ascertain that a quorum is present before proceeding to the business of the meeting. If a quorum has not been made within one-half hour after the appointed time, the meeting shall stand adjourned until the next meeting date or until another meeting has been called in accordance with this policy.
- 5. In the event both the Chair and Vice Chair are absent the trustees that are present shall appoint a trustee to Chair the meeting.
- 6. After a meeting has commenced, if notice is drawn to a lack of quorum, the presiding officer shall adjourn the meeting to the next regular meeting date or to another meeting called in accordance with this policy.
- 7. The agenda and notice of meetings shall be prepared under the direction of the Chair in consultation with the Vice Chair, the Superintendent and the Secretary-Treasurer. Proposed items may be placed on the Agenda in one of the following ways:
  - 1. By notifying the Board Chair, Vice Chair or Superintendent 24 hours prior to the agenda setting meeting.
  - 2. By notice of motion at the previous meeting.
  - 3. As a request from a committee of the Board.
  - 4. As outlined in Section 10 of this Policy.

- 8. The proposed agenda and supporting documentation will be posted on the district website on Friday afternoon prior to the meeting. Written notice of each meeting, together with the proposed agenda, must be given to each trustee to the place designated by them at least 24 hours prior to the agenda being made public. Non-receipt by a trustee shall not void the proceedings.
- 9. The order of business at regular Board meetings shall be:
  - a) approval of agenda
  - b) approval of minutes
  - c) public participation: comments and/or questions concerning the agenda
  - d) presentation
  - e) action items
  - f) information items
  - g) in-camera meeting summary
  - h) public participation: questions concerning the agenda
  - i) adjournment
- 10. A change to the order of business may be proposed by any trustee at the adoption of the agenda. Any addition to the agenda, or change to the order of business, shall require a majority vote.
- 11. Minutes of the proceedings of meetings shall be stored in digital format certified as correct by the Secretary-Treasurer or other employee designated by the Board under the *School Act*, and signed by the Chair or other member presiding at the meeting or at the next meeting at which the minutes are adopted.
- 12. The minutes of the regular public meeting shall be open for inspection at all reasonable times.
- 13. A meeting shall stand adjourned at three hours after its commencement unless a resolution is passed by a majority vote to extend the hour of adjournment.
- 14. The meetings shall be open to the public.
- 15. If the Secretary-Treasurer is unable to attend the meeting, another employee must be appointed as acting Secretary-Treasurer, for the purpose of the meeting, to record motions and their disposition.

16. The Chair or other member presiding at a meeting may expel from the meeting a person, other than trustee, that the Chair or other member presiding at the meeting considers guilty of improper conduct. A majority of the trustees present at a meeting of the Board may expel a trustee from the meeting for improper conduct.

# 220 POLICY Public Participation

The Board of Education believes that communication with the public is extremely important. The public Board meeting is the formally designated means of transacting Board business. Two One public participation periods are is therefore provided solely as a means for ensuring that community members who are present in the audience have an opportunity to provide comments and/or ask questions about business or issues pertaining to the Board.

The public participation period at the beginning end of the Board meeting is open to comments and/or questions concerning the agenda. The public participation period at the end of the Board meeting is open to questions concerning the agenda.

Speakers must identify themselves before speaking. The public participation periods will be a maximum duration of forty minutes each. Individuals speakers will be limited to ene comment or question at a time and a total of two minutes per speaker question. The Chair will indicate another means of response if the questions cannot be answered at the time.

Community members who have other comments or questions are encouraged to contact Trustees or the Superintendent or, if desired, to request arrange a formal presentation on the Board agenda. In general, Board policy indicates that questions or concerns are best handled as near the location of the issue as possible.

Matters currently under negotiation or litigation, or related to personnel, will not be discussed in the public participation question periods.

The Chair shall have the authority to terminate the remarks of any individual who does not adhere to this policy.

Persons addressing the Board are reminded that, although requests or questions may be directed to the Board, actions or answers to many questions may be deferred pending Board consideration.

RE: SAFETY BELTS ON BUSES

According to Transport Canada (TC), school bus travel continues to be the safest means for transporting children to and from school.

School bus safety is a shared responsibility. Federal and provincial school boards and school bus operators each play a role in making sure our school buses are safe. Transport Canada is responsible for establishing the Canadian Motor Vehicle Safety Standards which includes specific safety requirements for school buses. Last year the House of Commons Transportation Committee launched an investigation into bus safety, including school buses. The Committee's final report includes a number of recommendations to beef up safety requirements for passenger buses, including long-distance coaches and municipal transit buses. But the committee says conflicting evidence from experts about seatbelts on school buses points to the need for further study.

On July 11, 2018, the Motor Vehicle Safety Regulations were amended with technical requirements for how to install seat belts on school buses if a school bus operator chooses to install them.

#### The amendment:

- Tells manufacturers how to properly install lap-shoulder seat belts on school buses
- Does not allow manufactures to install lap-only seat belts
- Improves compartmentalization for larger students by raising the minimum seat back height

Manufacturers need to comply with these standards as of September 1, 2020. This amendment does not state that this is mandatory to put seatbelts in, only that if we do, this is the guideline to follow.

School buses are not passenger vehicles. They are built to rely on passive safety—not on seat belts—and are designed and constructed differently from passenger cars. They are bigger, heavier, and sit higher off the ground. They have unique roof strength, body joint strength, and compartmentalization requirements.

Compartmentalization is a design that includes:

- Seats with high backs;
- Seats filled with energy-absorbing material;
- Seats placed close together to form compartments;
- Strong seat anchorages.

Combination lap and shoulder belts would require stiffer seats, which could increase injury to students who are not buckled up. Unions and associations that represent bus drivers have raised concerns about liability when it comes to making sure children are properly belted for trips to and from school. Moreover, the shoulder belts can lead to abdominal injuries because of "submarining" – when children slip down, risking injuries to organs covered by the lap belts.

Beyond certain engineering problems, someone would need to ensure the seat belts are used, adjusted properly between uses by smaller children and larger children, and repaired when damaged. In an emergency, seatbelts could hinder evacuation. Young children should not be placed in a situation where they are responsible for their safety.

The safety issues around seat belt use in school buses is not clear. We would all agree the safety of students would improve in a roll over crash or severe sides impact (these are the two types of accidents with school buses that are the least frequent). In the case of a fire or emergency evacuation due to an accident, we *may* actually see more injuries and fatalities over all.
