## Assessment and Evaluation Day Outcomes:

These days need to offer flexibility and choice for our staff, connected to key areas of our School and District goals in order to engage staff. Our staff are in different places in their learning journey, with a range of comfort levels and expertise connected to assessment, evaluation and communicating student learning (CSL).

Session One for each day is reserved for each school staff to work together on a key topic. The principal will work with the school based pro-d committee to plan this session. All staff attend (CTA & CUPE).

Sessions 2-4 are designed for teaching staff to have some flexibility and choice in how best to utilize their time. Sessions will be offered by the District/School that are connected to our strategic goals, with the goal of ensuring we have "confident teaching staff, able to implement the goals of our strategic plan."

Teachers, who are confident in these areas (assessment, evaluation, CSL) have the choice of attending these sessions, or of using the time in the way they see best.

**Example Topics:** District / Provincial Assessments (ACT, SNAP, SWWs, Primary Screeners), Class Profile Use, Paradigm Use, IEP Goal Setting and Assessment, Student Self-Assessment Strategies plus school-based examples.
