INSURANCE:

All user groups must either provide a copy of their Liability Insurance policy, which must indicate two things:

1. “Board of Education, School District No.33 (Chilliwack)” is named as an “Additional Insured”, and
2. A minimum of 2 million in liability coverage; or

Must purchase insurance coverage through the District; the charges will be determined once information pertaining directly to the rental has been provided.

ADDITIONAL FEES:

A \$10.00 administrative fee will be applied to all contracts as well as GST (5%)

C1 – Any School District based function (i.e. PAC, Employee Wellness)

C2 – Youth/family groups that are facilitated/coached by volunteers (i.e. minor sports, etc.) and there is no money or honorarium exchanging hands and Partner Groups as per the NLC website

C3 – ALL adult or family/youth groups, health services, community clubs that provide programming/services by paid facilitators/coaches (i.e. general community groups, clubs, etc.)

C4 – Business/Political/Church (user groups that operate a “For Profit” organization)
